Uzbekistan E-visa Instructions



You can only apply for an e-visa if you are travelling to Uzbekistan within the next 3 months. Citizens of 51 countries (including most EU countries, the United States, Australia, and New Zealand) are eligible for an electronic tourist visa. The list of eligible nationalities is available here.

Before you start filling in the application, get your photo and passport copy ready. See examples on the next page.

Prerequisites for the photo are 35x40 mm size, 300 dpi resolution, and no more than 1 MB file size. The passport scan should be easily readable and no more than 500 KB. Only the main page is needed.

The visa will cost you 20 USD.

Currently, the system only accepts payments made with Visa cards.

Once your photo, passport copy, and visa card are ready, the next step is filling in the application at https://e-visa.gov.uz/main.

To start, click on the Application for e-visa button.























The period of stay must not exceed 30 days between the date of submission and completion of the validity period.





We recommend ignoring the "Surname changed" and "Name changed" tick boxes. In our experience, completing these often results in a system error at the end.



We recommend ignoring the "Citizenship of other states" tick box. Again, completing this often results in a system error at the end. When completing the application for the e-visa, you should enter the details of the passport you intend to use to enter Uzbekistan.

There should be no need for dual citizens to provide information on their other passport to obtain the e-visa, or to show this other passport when entering or travelling around Uzbekistan.
